FROM OUR BOARD AND LEADERSHIP

Since 1998, working throughout the Greater Cincinnati Area, local Assistance League members have worked diligently to build relationships with donors, supporters and sponsors that would allow us to grow and expand our program outreach.

A strong board with diligent leaders created an atmosphere that promoted a new initiative in 2017. Focused on Foster children being served by friends, relatives and others through Kinship Foster Care, a pilot program was created. When it was implemented with Cincinnati Children's Hospital Medical Center, it proved very successful. In 2018, the program was expanded to serve Foster Children in Kinship Care in several locations around the Greater Cincinnati Area.

We have continued to research ways to reach out to more children being thrust into Foster care by circumstances beyond their control. Many are victims of the opioid crisis which professionals tell us is not getting appreciably better.

We are also researching ways to improve the lives of children affected by poverty through our Operation School Bell Program. Our largest and longest standing program, it provides new school clothes to children in over 40 schools each year.

Now in our 22nd year we are grateful for all the support of donors, partners, sponsors and grant funders. Our all-volunteer membership is committed to meeting unmet needs and works every day to meet our mission. We express appreciation on behalf of our board and members. KINSHIP FOSTER CARE (Our newest program)

This program was started in 2017. We supply necessary items to children placed with relatives or family friends. These caregivers are not supported financially as are licensed Foster Care providers.

OPERATION SCHOOL BELL®

Started in 1998, students from area schools are given new school clothes every fall. We offer pants, shirts, underwear, socks and a fleece jacket.

ASSUALT SURVIVOR KITS®

Provide sweat suits, underwear, and toiletries to victims of sexual assault whose clothes are often taken as evidence. These items are provided through area hospitals. Started in 1996.

DOMESTIC VIOLENCE KITS

Started in 1997, this program provides necessities to women in domestic abuse shelters.

NEW BEGINNINGS

Starting a stable life after leaving a shelter can seem daunting. We provide essential supplies such as cookware, cleaning supplies dishes, linens and other items to make the transition easier.

Comforting items are also supplied to children. Started in 2010.

COLLEGE STARTER KITS

Basic school supplies are offered to financially challenged students struggling to pay for these needed supplies. Started in 2006.
