OPERATION SCHOOL BELL - CHAPTER MEMBERS PURCHASED AND DISTRIBUTED NEW SCHOOL UNIFORMS - WHICH INCLUDED PANTS, SHIRTS, FLEECE JACKETS, UNDERWEAR, SOCKS AND A BELT PACKAGED IN A TOTE BAG. STUDENTS PARTICIPATING IN THE PROGRAM WERE BROUGHT BY SCHOOL BUS FROM 36 AREA SCHOOLS. THIS PAST YEAR 3,826 CHILDREN FROM PUBLIC AND PAROCHIAL SCHOOLS IN CINCINNATI AND NORTHERN KENTUCKY PUBLIC WERE CLOTHED. ASSISTANCE LEAGUE HAS PROVIDED 28,202 SCHOOL UNIFORMS TO STUDENTS SINCE THE PROGRAM BEGAN IN 1998.

NEW BEGINNINGS - CHAPTER MEMBERS AND DONORS PURCHASE ESSENTIAL HOUSEHOLD ITEMS AND ITEMS FOR INFANTS AND CHILDREN. THESE ITEMS ARE DIVIDED INTO CLEANING, BED/ BATH, AND KITCHEN ITEM SETS AS WELL AS SETS FOR CHILDREN. THE SETS ARE DISTRIBUTED TO WOMEN AND CHILDREN WHO ARE VICTIMS OF DOMESTIC VIOLENCE AND ARE LEAVING THE SHELTERS TO ESTABLISH A HOME AWAY FROM THEIR ABUSERS. IN THE PAST YEAR, 138 HOUSEHOLDS WITH 139 CHILDREN RECEIVED SETS IN HAMILTON COUNTY, CLERMONT COUNTY AND NORTHERN KENTUCKY. SINCE THIS PROGRAM BEGAN IN 2010, 1,014 WOMEN AND 1,017 CHILDREN HAVE BENEFITTED FROM THIS PROGRAM.

ASSAULT SURVIVOR KITS ARE KITS CONTAINING SWEAT PANTS, SWEATSHIRT OR TEE SHIRT, SOCKS, UNDERWEAR AND HYGIENE ITEMS PACKAGED IN REUSABLE DRAWSTRING BAGS BY CHAPTER MEMBERS AND DELIVERED TO HOSPITALS IN THE GREATER CINCINNATI AREA. WE PRESENTLY SERVE THREE HOSPITALS IN HAMILTON COUNTY, FIVE IN BUTLER COUNTY, ONE IN CLERMONT COUNTY AND SIX IN NORTHERN KENTUCKY. THE KITS ARE GIVEN TO VICTIMS OF ASSAULT AND RAPE. 727 KITS WERE DELIVERED THIS PAST YEAR. IN THE PAST SEVEN YEARS, 5,194 WERE DELIVERED.
