OPERATION SCHOOL BELL - STUDENTS FROM 22 AREA PUBLIC AND PAROCHIAL SCHOOLS CAME BY BUS TO THE CHAPTER'S CENTER WHERE MEMBERS AND COMMUNITY VOLUNTEERS HELPED THEM SELECT NEW PANTS, SHIRTS, FLEECE JACKET, UNDERWEAR, SOCKS, AND A BELT FOR SCHOOL WEAR. IN ADDITION, CHAPTER MEMBERS, UNIVERSITY STUDENTS, AND OTHER COMMUNITY VOLUNTEERS HELPED ASSEMBLE MULTIPLE SIZES OF BOXED NEW CLOTHES WHICH WERE PROVIDED TO 19 AREA PUBLIC AND PAROCHIAL SCHOOLS FOR DISTRIBUTION TO STUDENTS AT THEIR SITES. FOR THE FISCAL YEAR ENDED MAY 31, 2019, ASSISTANCE LEAGUE HELPED CLOTHE 4,656 STUDENTS. SINCE THE PROGRAM BEGAN LOCALLY IN 1998, THE CHAPTER HAS PROVIDED SCHOOL UNIFORM CLOTHING TO 32,858 STUDENTS.

NEW BEGINNINGS - CHAPTER MEMBERS AND DONORS PURCHASE ESSENTIAL HOUSEHOLD ITEMS AND ITEMS FOR INFANTS AND CHILDREN. THESE ITEMS ARE DIVIDED INTO CLEANING, BED/BATH, AND KITCHEN ITEM SETS AS WELL AS SETS FOR CHILDREN. THE SETS ARE DISTRIBUTED TO WOMEN AND CHILDREN WHO ARE VICTIMS OF DOMESTIC VIOLENCE AND ARE LEAVING THE SHELTERS TO ESTABLISH A HOME AWAY FROM THEIR ABUSERS. IN THE PAST YEAR, 135 HOUSEHOLDS WITH 135 CHILDREN RECEIVED SETS IN HAMILTON COUNTY, CLERMONT COUNTY AND NORTHERN KENTUCKY. SINCE THIS PROGRAM BEGAN IN 2010, 1,149 WOMEN AND 1,152 CHILDREN HAVE BENEFITTED FROM THIS PROGRAM.
